

RESOLUTION NO. 202381 APR 8 1971

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO  
REQUESTING THE CONSOLIDATION OF A SPECIAL MUNICIPAL  
ELECTION TO BE HELD IN THE CITY OF SAN DIEGO ON  
JUNE 8, 1971, WITH THE COUNTY SPECIAL ELECTION TO  
BE HELD ON THE SAME DATE.

WHEREAS, this Council intends to call a special election to be held on June 8, 1971, for the purpose of submitting to the voters of the City a proposition as set forth in this resolution calling for the opinion of the electorate on the question of whether or not the City Council of the City of San Diego should consider calling an election on the question "Shall a Charter Commission be elected to propose a new charter or to revise the current charter?"; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Board of Supervisors of the County of San Diego is hereby requested to consolidate the special municipal election to be held for the purpose of determining the opinion of the electorate on the question of whether or not the City Council of The City of San Diego should consider calling an election on the question "Shall a Charter Commission be elected to propose a new charter or to revise the current charter?" in the City of San Diego on June 8, 1971, with the County Special Election to be held on the same date.

2. The exact form of the proposition to be voted upon at this special municipal election and as it is to appear on the ballot is as follows:

PROPOSITION _____ SOLICITING THE OPINION OF THE PEOPLE OF SAN DIEGO ON THE QUESTION:  Shall the City Council of The City of San Diego consider calling an election on the question "Shall a Charter Commission be elected to propose a new charter or to revise the current charter?"	YES

The proposition shall be designated on the ballot by a letter printed on the left margin of the square containing the description of the measure as provided in Section 10231 of the Elections Code of the State of California.


3. The Board of Supervisors is hereby authorized to canvass the returns of this special municipal election and is requested to conduct the elections in all respects as if there were only one election using only one form of ballot.

4. The Board of Supervisors is hereby requested to issue to all officers of the County charged with duties pertaining to the County Special Election, instructions to take any and all steps necessary for the holding of the consolidated election.

5. The City Clerk is hereby directed to file a certified copy of this resolution with the Board of Supervisors and the Registrar of Voters of the County of San Diego.
