

RESOLUTION NO. 202406 APR 13 1971

WHEREAS, The City of San Diego has had for a number of years a strong interest in the development, reconstruction and restoration of the Old Town area; and

WHEREAS, State Senators and Assemblymen have helped promote State interest in development of the Old Town area; and

WHEREAS, the California State Legislature has heretofore appropriated the sum of two and one-half million dollars for the acquisition of land within the area known as the Old Town State Park Project area; and

WHEREAS, The City of San Diego entered into an agreement with the State of California dated April 27, 1967 for the care, maintenance, development and control of the Project; and

WHEREAS, said agreement provides that all expenditures by State, other than those which had been appropriated and authorized, shall be subject to the availability of funds and the mandates of the Legislature; and

WHEREAS, The City of San Diego has provided at City expense a minimum of 150 additional parking spaces within 1,000 feet of said Park area; and

WHEREAS, The City of San Diego has donated City-owned property valued at approximately \$350,000 for the Old Town State Park Project; and

WHEREAS, due to a multitude of economic pressures, funds have not been available to the State for development of the Old Town State Park Project as scheduled; and


WHEREAS, due to the economic impact on the City and on the property surrounding the Project area, it is City's desire that development of the Park Project and/or its use proceed as expeditiously as possible; and

WHEREAS, the City may have some capacity to generate funds for the development of the Project area as planned; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego urgently requests that the Legislature of the State of California authorize a lease to be entered under which the Old Town State Park Project area is leased by the State Department of Parks and Recreation to The City of San Diego upon terms to be mutually agreed on, in order that the development and/or the interim use of the Park may proceed without further delay.
