A RESOLUTION REGARDING THE OPERATION
OF THE SAN DIEGO NEIGHBORHOOD COMMUNITY
RELATIONS BOARD PROJECT BY THE MODEL
NEIGHBORHOOD COMMUNITY RELATIONS
DEPARTMENT, CITY OF SAN DIEGO.

WHEREAS, The City of San Diego, California, has entered into a contract with the Department of Housing and Urban Development of the United States of America for a grant to carry out, within the City of San Diego, a Model Cities Program; and

WHEREAS, the Comprehensive Demonstration Plan authorized by Resolution No. 199764 of the San Diego City Council was approved by HUD and designates The City of San Diego as the operating agency for the Neighborhood Community Relations Board Project; and

WHEREAS, the Grant Agreement for Program No. SDMC-S-7 provides Model Cities supplemental funds for the operation of said Project; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That The City of San Diego, operating through its Model Neighborhood Community Relations Department, under the direction of the City Manager hereby assumes full responsibility for the implementation and operation of the Neighborhood Community Relations Board Project of the San Diego Model Cities Program.

BE IT FURTHER RESOLVED, that to the extent permitted by law and its Charter, the City shall operate said Project in accordance with the terms and conditions specified in the Operating Agency Agreement as modified by additions and interlineations and in accordance with the attachments thereto, which together with said agreement are on file in the office of the City Clerk as Document No. 735644.

BE IT FURTHER RESOLVED, that the Project budget in the amount of \$80,000 is hereby approved and the expenditure of \$80,000 is hereby authorized out of Model Cities First Action Year Fund 2901 of The City of San Diego, solely and exclusively for the purpose of providing funds for the operation of said Project.
