WHEREAS, INDUSTRIAL DEVELOPERS, LTD., by Clark E. Higgins, applied to the City Council for special permission to waive underground electrical line requirements in connection with the subdivision map of VIA SORRENTO VALLEY INDUSTRIAL PARK UNIT NO. 6; and

WHEREAS, the subdivider has signed a restrictive covenant agreeing not to oppose future 1911 Act underground installation; and

WHEREAS, the subdivider has agreed that the 12KV line will be placed underground when the 69KV line is placed underground in the Flood Channel; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The application for waiver of undergrounding of electrical line requirements in connection with VIA SORRENTO VALLEY INDUSTRIAL PARK UNIT NO. 6 subdivision is hereby granted as to that portion of the electrical lines located within the Flood Channel as shown on the above-mentioned subdivision map.
