

RESOLUTION NO. 202428 APR 15 1971

APPROVING MAP OF CORONADO TERRACE UNIT NO. 2 AND
ACCEPTING ON BEHALF OF THE PUBLIC THE PORTION OF
PUBLIC STREET DEDICATED ON SAID MAP, AND ACCEPTING
ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENTS
GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by JOSEPH C. BROWN, Registered Civil Engineer, and entitled,
"CORONADO TERRACE UNIT NO. 2 Being a subdivision of portions
of Lots 47, 48, 49, 57, to 61 inclusive, 64, and all of Lots 62
and 63 of Nestor Acres in the City of San Diego, County of San
Diego, State of California, according to Map thereof No. 1768,
filed in the office of County Recorder of San Diego County,
November 21, 1923.", is made in the manner and form prescribed by
law and conforms to the surrounding surveys; that said map and
the subdivision of land shown thereon is hereby approved and
accepted; and said Council hereby accepts on behalf of the public,
the portion of public street, to wit: portion of Grove Avenue,
for public purposes and said portion of a street is hereby
delcared to be portion of a public street and dedicated to the
public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on
behalf of The City of San Diego the easements shown on Sheet 2
of this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and that those certain easements as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
