That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to an agreement with HOMER DELAWIE AND ALFONSO MACY, A.I.A., architects, for architectural and engineering services in connection with the developments in Balboa Park, under the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 735636.

BE IT FURTHER RESOLVED, that the expenditure of \$8,000 is hereby authorized from Park and Recreation Bond Fund 725, solely and exclusively for the purpose of providing funds for the architectural and engineering services described above and related construction expenses, and supplementing Resolution No. 193647 in this amount.
