This Council finds and hereby declares that the findings of the Planning Commission set forth in Resolution No. 273-PC are supported in all particulars by the testimony, minutes, tape of the proceedings, maps and exhibits, all of which are herein incorporated by reference, and said findings are hereby adopted as the findings of this Council.

BE IT FURTHER RESOLVED, that by a vote of 5 to 2, the appeal of ALPHA-OMEGA BUILDING FUND, INC., by Robert L. Smith, President, be, and it is hereby denied; and the decision of the Planning Commission denying a conditional use permit to operate and maintain a fraternity house be, and it is hereby upheld.
