

RESOLUTION NO. 202451 APR 20 1971

APPROVING MAP OF MIRA MESA VERDE UNIT NO. 5 SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND PORTIONS OF PUBLIC STREETS DEDICATED ON SAID MAP WITHIN THIS SUBDIVISION.


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM J. CLARKE, Licensed Land Surveyor, and entitled, "MIRA MESA VERDE UNIT NO. 5 Being a subdivision of a portion of Lot 1, Northwest Quarter of the Northwest Quarter of Section 31, Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to Official Plat thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets and portions of public streets, to wit: Via San Blas, Calliandra Road, Duncan Road, Belgian Street, Polaris Street, Brentford Avenue, Dewsbury Avenue, a portion of Westonhill Drive and a portion of Westmore Road for public purposes, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
