

RESOLUTION NO. 202455 APR 20 1971

WHEREAS, Chapter VI, Article 1, Division 6 of the San Diego Municipal Code provides for methods by which open space lands may be acquired, improved and maintained for park and recreation purposes; and

WHEREAS, one of the methods so provided is by initiation of proceedings by resolution of the City Council; and

WHEREAS, it is contemplated that such a park district be formed in the KEARNY VISTA-CLAIREMONT MESA AREA; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby directed to file an application with the United States Department of Housing and Urban Development for any grant or funds available for such a park district, to prepare plans for the acquisition, improvement and maintenance of the lands shown on Exhibit A together with the estimates of the costs and expenses of such acquisition, improvement and maintenance, to prepare an estimate of the assessment to be levied on each parcel of property within the proposed district, and to furnish this Council with a description of the district and a plat showing the boundaries of the district to be included in the assessment for said acquisition, improvement and maintenance; said acquisition, improvement and maintenance to be done under the San Diego Park District Procedural Ordinance of 1969.
