BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$31,444.00 by L. R. Hubbard, Jr., an individual dba Hubbard Construction Company for the CONSTRUCTION OF MALL AND WALKS IN THE OLD GLOBE THEATRE AREA OF BALBOA PARK, including Additive Alternates #1 and #2, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 735191.
2. That the expenditure of \$32,400.00 is hereby authorized out of the Park and Recreation Bond Fund 725 of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF MALL AND WALKS IN THE OLD GLOBE THEATRE AREA OF BALBOA PARK, including Additive Alternates #1 and #2, in the City of San Diego, and related costs to supplement Resolution No. 195275 in this amount.
