

RESOLUTION NO. 202487 APR 22 1971

APPROVING MAP OF SPREE SUBDIVISION AND ACCEPTING
ON BEHALF OF THE PUBLIC THE PUBLIC STREETS
DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF
OF THE CITY OF SAN DIEGO, THE EASEMENTS GRANTED
ON THIS MAP WITHIN THIS SUDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by JOHN M. LEACH, Registered Civil Engineer, and entitled,
"SPREE Being a subdivision of a portion of Lot 70 of
Rancho Mission of San Diego, in the City of San Diego, County
of San Diego, State of California according to Referee's Partition
Map of a portion of said Lot 70 made in action entitled
"San Diego Realty Company vs. Maria Y. Olvera De Toro Et.Al.,"
said Map being filed in the office of the County Clerk of
San Diego County in Civil Case No. 15191.", is made in the
manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public, the public streets,
to wit: Whelan Drive, Barker Drive, Barker Way, Coleshill Drive,
Boulder Lake Avenue, Acuff Drive and Regner Road, for public
purposes, and said streets are hereby declared to be public
streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
