RESOLUTION ORDERING WORK TO IMPROVE AND TO ESTABLISH THE GRADE IN THE ALLEY, BLOCK 61, LINDA VISTA UNIT NO. 4, ALLEY, BLOCKS 30, 34 AND 57, LINDA VISTA UNIT NO. 5, ALLEY, BLOCKS 18 AND 22, LINDA VISTA UNIT NO. 6, AND ALLEY, BLOCKS 23 AND 34, LINDA VISTA UNIT NO. 8; AND TO IMPROVE EAST AND WEST JEWETT STREET, DUNLOP STREET, WEST DUNLOP STREET, DRESCHER STREET, LANGMUIR STREET, EASTMAN STREET AND WATERMAN COURT.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest and convenience require the improvement herein referred to, and that this Council hereby orders that the work and improvement as described in Resolution of Intention No. 202032, passed and adopted by the City Council on MAR 2 1971, and the plans, profiles and specifications therein referred to, be done and made.

2. That the boundaries of the district to be assessed and the grades to which said work is to be done, shall be those described in said Resolution of Intention, and the plans, profiles and specifications therein referred to, reference to which is hereby made to all particulars.

3. The Purchasing Agent of The City of San Diego is hereby declared to be the officer to whom bids for such improvement work shall be presented or delivered; and the Purchasing Agent is hereby directed to post conspicuously, for five days, on or near the Council door, in the manner and form prescribed by law, the notice, together with a copy of the prevailing wage schedule established by Resolution

No. 201879, inviting sealed proposals or bids for doing the work ordered. Such notice shall state that the Purchasing Agent is the officer designated by the City Council to receive such bids and such notice shall give the time and place of the opening of any bids so received; and the Purchasing Agent is hereby directed to publish twice in the City Official Newspaper a notice inviting such proposals for doing the work; and the Purchasing Agent is hereby directed to record the results of such bidding to the City Council at the next regular City Council meeting after the opening of the bids.
