RESOLUTION APPROVING THE PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 202111 FOR THE IMPROVEMENT OF 40TH STREET, IMPERIAL AVENUE, AND FRANKLIN AVENUE.

WHEREAS, this City Council did on March 9, 1971, adopt Resolution of Intention No. 202111 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that, (1) certain changes and modifications be made in the proposed work to be done in the said Resolution of Intention, and (2) that said Resolution of Intention be amended by the (A) incorporation of an alternate paving schedule to provide for deep-strength asphalt concrete pavement, and (B) the deletion of one street light from the quantities indicated in the specifications to agree with that work shown on the plans; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the plans, drawings, typical cross-sections, profiles and specifications for the improvement of 40TH STREET, IMPERIAL AVENUE and FRANKLIN AVENUE, heretofore filed in the office of the City Clerk as Document No. 735036 and approved by Resolution No. 202110, and as modified and amended by Resolution No. 202318 be, and the same are amended to conform with City of San Diego Engineering Department Drawing Nos. 13680-1-D through 13680-12-D, filed in the office of the City Clerk as Document No. 735734, and the same are hereby approved and

adopted as the official drawings, typical cross-sections,
profiles and specifications for said work and improvements.
