

RESOLUTION NO. 202529

APPROVING MAP OF THE KNOLLS OF DEL CERRO UNIT NO. 2
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE
PUBLIC STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON
BEHALF OF THE CITY OF SAN DIEGO, THE EASEMENTS GRANTED
ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed
by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled,
"THE KNOLLS OF DEL CERRO UNIT NO. 2 Being a subdivision of a
portion of Lot "F" of the Partition of a portion of Lot 70 of
Rancho Mission of San Diego, in the City of San Diego, County of
San Diego, State of California, according to Map thereof made in
Action No. 15191 of the Superior Court of San Diego, entitled
"San Diego Realty Company Vs. Maria Y. Olvera De Toro, et al." filed
in the office of the County Clerk of said County.", is made in the
manner and form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown thereon
is hereby approved and accepted; and said Council hereby accepts on
behalf of the public, the public streets, to wit: Laurelridge Road,
Laurelridge Court, Clear Sky Terrace, Mountain Top Court, Ridge
Route Road, Lofty View Point, Lazy Clouds Point, High Winds Way,
Town View Lane, Town View Terrace, and Town View Court, for public
purposes, and said streets are hereby declared to be public streets
and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
