

RESOLUTION NO. 202537

WHEREAS, the City Council on March 9, 1971 approved by Resolution No. 202119 the issuance and sale of San Diego Planetarium Authority Revenue Bonds; and

WHEREAS, the City Council on March 11, 1971 adopted Ordinance No. 10522 (New Series) authorizing the execution of a Sublease from the San Diego Planetarium Authority to the City of the Planetarium facilities, which Sublease is on file in the office of the City Clerk as Document No. 735607; and

WHEREAS, said Sublease, under Section 4, subdivision (a), provides for a Base Rental of \$250,000 per year based upon an assumed rate of interest on said Bonds; and

WHEREAS, said Sublease, under Section 4, subdivision (f), provides for an adjustment to the Base Rental when the actual interest rates on said Bonds are ascertained; and

WHEREAS, said Bonds were awarded on April 13, 1971, and the interest rates thereon have now been ascertained; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That pursuant to Section 4, subdivision (f) of said Sublease, an adjustment of the Base Rental from \$250,000 to \$246,750, which figure is based upon the actual interest rates on said Bonds, and the San Diego Planetarium Authority Schedule of Annual Bond Service, a copy of which is on file with the City Clerk as Document No. 735725, are hereby approved.
