WHEREAS, the Planning Commission of The City of San Diego has heretofore held a public hearing to consider the adoption of the ELLIOTT COMMUNITY PLAN; and

WHEREAS, the plan will serve as a guide for the development of an area comprising approximately 10,120 acres of land bounded generally by the Camp Elliott military reservation on the north; Sycamore Canyon on the east; Friars Road and the San Diego River on the south; and Murphy Canyon on the west; and

WHEREAS, on March 24, 1971, the Planning Commission adopted and recommended for approval to the City Council the ELLIOTT COMMUNITY PLAN; and

WHEREAS, the Council of The City of San Diego has held a public hearing to consider said plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

This Council hereby adopts that plan consisting of a report entitled ELLIOTT COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. 735773, excluding from said report that portion of the ELLIOTT COMMUNITY PLAN which lies within Sound Intensity Zone 2 as shown on the aforementioned plan.
