Charles F. Reeves	RECREATION	\$250	Each year several hundred rowboats are moved from one reservoir to another. The suggested use of small, inexpensive trailers has made this possible with less costly equipment and much less time for personnel. It is expected that over \$5,000 a year in savings will be made. An additional advantage is that the moves can be made entirely with Recreation personnel. Other departments do not have to be depended on.
Margarett C. Smith	LIBRARY	\$140	An entirely new system of handling over 40,000 overdue book notices a year was developed by the suggester, using a Xerox reader-printer. The estimated net saving is about \$1,400 a year. In addition the return of books has doubled and public acceptance of the new notice has been much better. An acute clerical situation has also been alleviated.
