Russell Schmidt Larry Munsterman	POLICE DEPARTMENT Animal Regulation	\$35	The suggesters discovered that a charge was being made to the City for an unused gas meter outside the City Pound. They had it removed for a saving of \$350 during the time Animal Regulation continued to be operated by the City.
Marie Pugh	CITIZENS ASSISTANCE Information Center	\$10	The use of the Parkade Terrace for parking City vehicles was proposed and instigated by the suggester. This results in a better location for Council, Manager and Attorney cars and frees space for the public.
Marilyn Menconi	WATER UTILITIES Customer Service Division	\$10	It was suggested that a number be added to error memos to save time in locating the original document. This saves about \$64 a year of clerical yime.
John Scott	PUBLIC WORKS DEPARTMENT Communications Division	\$10	A circuit change in a certain make of radio was proposed to reduce failures. It is estimated that this saved \$69 in a year. Only a small number of units is involved.
