

RESOLUTION NO. 202627 MAY 13 1971

WHEREAS, the City Council has in Resolution No. 202464 declared that certain weeds, rubbish, refuse and dirt existing on private property as described in Document No. 735654 on file in the office of the City Clerk constitute a public nuisance; and

WHEREAS, the Council has in said resolution declared its intention to order the abatement of same; and

WHEREAS, the hearings provided for in said resolution for the consideration by the Council of factual showings by affected property owners why said nuisance should not be abated and any and all objections to the proposed removal of weeds, refuse, rubbish and dirt have been held at the time and place fixed therefor; and

WHEREAS, at said hearings all persons desiring to be heard were fully heard and all oral and written protests and objections, if any, were fully considered and this Council gave all persons present an opportunity to hear and be heard in respect to the proposed abatement; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:
