WHEREAS, the Council has in said resolution declared its intention to order the abatement of same; and

WHEREAS, the hearings provided for in said resolution and required by law have been held and all objections to the proposed removal of weeds, rubbish, refuse and dirt fully heard and considered; and

WHEREAS, the Council has in Resolution No. 202627 disposed of any and all objections made by overruling and denying same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Public Works Director of The City of San Diego, the person previously designated as the Superintendent in this matter, is hereby ordered to abate said nuisance by having the weeds, rubbish, refuse and dirt removed.
