BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$34,871.00 by R. E. Hazard Contracting Co., a corporation, for THE CONSTRUCTION OF THE SAN DIEGO WILD ANIMAL PARK SANITARY TRUNK AND OUTFALL SEWERS, WATER LINE, AND APPURTENANCES in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in the form on file in the office of the City Clerk as Document No. 735271.

2. That the expenditure of \$38,000.00 is hereby authorized out of the Wild Animal Recreational and Educational Facilities Bond Fund 731 of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF THE SAN DIEGO WILD ANIMAL PARK SANITARY TRUNK AND OUTFALL SEWERS, WATER LINE, AND APPURTENANCES in the City of San Diego, and related costs.
