

RESOLUTION NO. 202645

APPROVING MAP OF MIRADOR UNIT NO. 3 SUBDIVISION AND  
ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS  
AND PORTION OF PUBLIC STREET DEDICATED ON SAID MAP  
WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by R.M. GALLOWAY, Registered Civil Engineer, and entitled,  
"MIRADOR UNIT NO. 3 Being a subdivision of a portion of the  
East Half of the West Half and a portion of the Southwest Quarter  
of the Northwest Quarter of Section 25, Township 14 South, Range  
3 West, San Bernardino Meridian, in the City of San Diego,  
County of San Diego, State of California.", is made in the manner  
and form prescribed by law and conforms to the surrounding surveys;  
that said map and the subdivision of land shown thereon is hereby  
approved and accepted; and said Council hereby accepts on behalf  
of the public the public streets and portion of public street,  
to wit: Avenida del Gato, Santa Arminta Avenue, Los Sabalos  
Street, Calle Dario, Dedo Place, Calle Jalapa, Trebol Street,  
Calle del Humo, Calle Nuevo, Calle Pino, Surco Drive and a  
portion of Camino Ruiz for public purposes, and said streets and  
portion of street are hereby declared to be public streets and  
portion of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to  
endorse upon said map, as and for the act of the Council, that

said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
