RESOLUTION APPROVING THE PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 202401 FOR THE IMPROVEMENT OF 54TH STREET, EDISON STREET AND 51ST STREET.

WHEREAS, this Council did on April 13, 1971, adopt Resolution of Intention No. 202401 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said resolution of intention; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the proposed work to be done in said resolution of intention, and that said resolution of intention be amended by the deletion of those improvements on EDISON STREET located adjacent to a portion of Lot 2, Morena, Map No. 809; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the plans, drawings, typical cross-sections, profiles and specifications for the improvement of 54TH STREET, EDISON STREET and 51ST STREET, heretofore filed in the office of the City Clerk as Document No. 735530 and approved by Resolution No. 202400 be, and the same are hereby amended to conform with City

of San Diego Engineering Department Drawing Nos. 14471-1-D through 14471-3-D, filed in the office of the City Clerk as Document No. 735954, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvements.
