2. That the expenditure of \$20,000.00 is hereby authorized out of the Sewer Bond Fund 728 of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF SPRUCE STREET AND IBIS STREET in the City of San Diego, and related costs.
