RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO  
AWARDING A CONTRACT TO IMPROVE AND TO ESTABLISH THE GRADE  
IN THE ALLEY LYING BETWEEN BLOCK 3, FIRST ADDITION TO  
OCEAN SPRAY TRACT AND PORTION OF LOT 5, PUEBLO LANDS  
SUBDIVISION LOT 1783, AND THE ALLEY, BLOCK 38, FAIRMOUNT  
ADDITION; AND TO IMPROVE AND TO REESTABLISH THE GRADE IN  
THE ALLEY, BLOCK 48, TRACT 1368, RESUBDIVISION OF FAIR-  
MOUNT ADDITION.

hereby rejects all said proposals or bids except that herein  
mentioned and hereby awards the contract for doing said work  
and improvement to the lowest regular responsible bidder to wit:

at the prices named in the bid of said bidder on file in the  
office of the City Clerk.

The City Clerk is hereby directed to cause notice of this  
award to be published twice in the City Official Newspaper and  
to record notice of this award in the office of the County  
Recorder as provided in Section 5248 of the Streets and Highways  
Code.
