RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO,
CALIFORNIA, AWARING A CONTRACT TO IMPROVE AND TO
CHANGE THE GRADE ON CERVANTES AVENUE, AND TO IMPROVE AND
TO ESTABLISH THE GRADE ON PARADISE ROAD.

did on April 14, 1971 publicly open, examine and declare
all sealed proposals or bids for doing the work and improvement
described in Resolution of Intention No. 201310,

of Intention; NOW, THEREFORE,

as follows:

hereby rejects all said proposals or bids except that herein
mentioned and hereby awards the contract for doing said work
and improvement to the lowest regular responsible bidder to
wit: V. R. DENNIS CONSTRUCTION COMPANY

at the prices named in the bid of said bidder on file in the
office of the City Clerk.

The City Clerk is hereby directed to cause notice of this
award to be published twice in the City Official Newspaper and
to record notice of this award in the office of the County
Recorder as provided in Section 5248 of the Streets and Highways
Code.
