

RESOLUTION NO. 202722 MAY 20 1971

APPROVING MAP OF PARK RIDGE UNIT NO. 5 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "PARK RIDGE UNIT NO. 5 Being a subdivision of a portion of Lot "F" and a portion of Lot "G" in Lot 70 of Rancho Mission of San Diego, according to Map thereof made in Action No. 15191 entitled "San Diego Realty Company vs. Maria Y Olvera de Toro, et al", and a portion of Lot 67 of Rancho Mission of San Diego, according to Partition Map thereof made in Superior Court Action No. 348, entitled "Juan M. Luco, et al, vs. The Commercial Bank of San Diego, et al", all on file in the office of the County Clerk of San Diego County, in the City of San Diego, County of San Diego, State of California, together with portions of Navajo Road, Park Ridge Boulevard, and Oakridge Road, all dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public street and portion of public street, to wit: Park Ridge Boulevard and a portion of Navajo Road for public purposes, and said street and portion of street are hereby declared to be public street and

portion of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portion of public street are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
