BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Lease Agreement with ROBERT BREITBARD, an individual, and UNION OIL COMPANY OF CALIFORNIA, a corporation, amending that certain Lease Agreement between the parties which is on file in the office of the City Clerk as Document No. 714702, to adjust the boundary lines of the lease premises to reflect the deletion of right of way required for Kurtz Street extension and an area lying northeasterly of Kurtz Street, and the addition of City-owned land to replace the area deleted, under the terms and conditions set forth in the form of First Amendment to Lease Agreement, on file in the office of the City Clerk as Document No. 735971.
