APPROVING MAP OF MICHELS HOMESITE SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by W. D. HARGUS, Licensed Surveyor, and entitled, " MICHELS HOMESITE Being a subdivision of a portion of the South Half of the Southeast Quarter of Pueblo Lot 1255 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California according to Map thereof made by James Pascoe in 1870, a copy of which was filed in the office of the County Recorder of said County, November 14, 1921 and is known as Miscellaneous Map No. 36, and a portion of Cardeno Drive dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
