RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO  
AWARDING A CONTRACT TO IMPROVE AND TO ESTABLISH THE  
GRADES IN THE ALLEY, BLOCK F, CONGRESS HEIGHTS NO. 2,  
ALLEY, BLOCK 44, TRACT NO. 1368, RESUBDIVISION OF  
FAIRMOUNT ADDITION, AND ALLEY, BLOCK 177, PACIFIC  
BEACH.

and improvement to the lowest regular responsible bidder to  
wit: PACIFIC ENGINEERS  
at the prices named in the bid of said bidder on file in the  
office of the City Clerk.

The City Clerk is hereby directed to cause notice of this  
award to be published twice in the City Official Newspaper and  
to record notice of this award in the office of the County  
Recorder as provided in Section 5248 of the Streets and Highways  
Code.
