BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THOMAS L. HURST and GWENDA HURST, husband and wife, as joint tenants, as to an undivided one-half interest; and LEONARD H. FRAM and MARCIA E. FRAM, husband and wife, as joint tenants, as to an undivided one-half interest, executed in favor of The City of San Diego, bearing date April 4, 1971, conveying to said City an easement and right of way for water purposes, through, along and across a portion of the East Half of the West Half of the South Half of the Southwest Quarter of the Northwest Quarter of Section 28, Township 14 South, Range 3 West, San Bernardino Meridian, according to the United States Government Survey, approved May 20, 1884, as more particularly described on said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
