

RESOLUTION NO. 202769 MAY 25 1971


BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That the acceptance by the City Manager of that deed of PENASQUITOS, INC., an Illinois corporation, executed in favor of The City of San Diego, bearing date April 22, 1971, conveying to said City easements and rights of way for street purposes, through, over and across a portion of Lot 496 of Bay Terraces Unit No. 1, according to Map thereof No. 6659, filed June 1, 1970 in the Office of the San Diego County Recorder, together with easements for water, drainage and general utility purposes, as more particularly described in said deed, as certified by the Property Director be, and the same is hereby approved; and the landstherein conveyed as Parcels 1 and 2 are hereby dedicated as and for a public street and the same is hereby named CAMPHOR LANE, and the lands therein conveyed as Parcels 3 and 4 are hereby dedicated as and for a public street and the same is hereby named STONEPINE LANE, and the landstherein conveyed as Parcels 5, 6, 7, 8 and 9 are hereby dedicated as and for a public street and the same is hereby named PINECONE LANE, and the lands therein conveyed as Parcels 10, 11, 12, 13 and 14 are hereby dedicated as and for a public street and the same is hereby

named PARTHENON DRIVE, and the lands therein conveyed as  
Parcels 15, 16, 17, 18 and 19 are hereby dedicated as and  
for a public street and the same is hereby named REDBARK  
WAY.

That the City Clerk of said City is hereby authorized  
and directed to file, upon acceptance by the City Manager,  
the foregoing said deed for record in the office of the  
Recorder of San Diego County.
