

RESOLUTION No. 202776

Adopted on MAY 25 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a Fourth Amendment to Agreement with SOLAR, a Division of International Harvester Company, a Delaware corporation, amending that certain Sales Agreement between the parties which is on file in the office of the City Clerk as Document No. 69707, as amended, to (1) extend the option period five (5) years to April 28, 1976, (2) specify the amount of acreage contained in the option parcel, (3) extend the period for commencement of construction of 130,000 square foot and 230,000 square foot manufacturing facilities five (5) years to February 28, 1976 and February 28, 1978 respectively, and (4) provide for the transfer of approximately 8.1 net acres valued at \$45,846.00 from Solar to City as consideration for the foregoing amendments, under the terms and conditions set forth in the form of Fourth Amendment to Agreement, on file in the office of the City Clerk as Document No. 736003.
