

RESOLUTION NO. 202791 MAY 27 1971

APPROVING MAP OF FRIARS VILLAGE UNIT NO. 1 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "FRIARS VILLAGE UNIT NO. 1 Being a subdivision of a portion of Lot 2 of Monterey Club, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6591, filed in the office of the County Recorder of San Diego County February 20, 1970.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets, to wit: Camino Costanero and Camino Copete for public purposes and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Via Las Cumbres adjacent and contiguous to Lots 66-A, 67-A, 68-A, 69-A, 70-A, 71-A and 72-A, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego the easements granted in paragraphs 1, 2, and 3 in the Owners' Certificate therein and

subject to the conditions set forth therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access together with the easements as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
