in Section 36, Township 14 South, Range 3 West, S.B.B.M.,

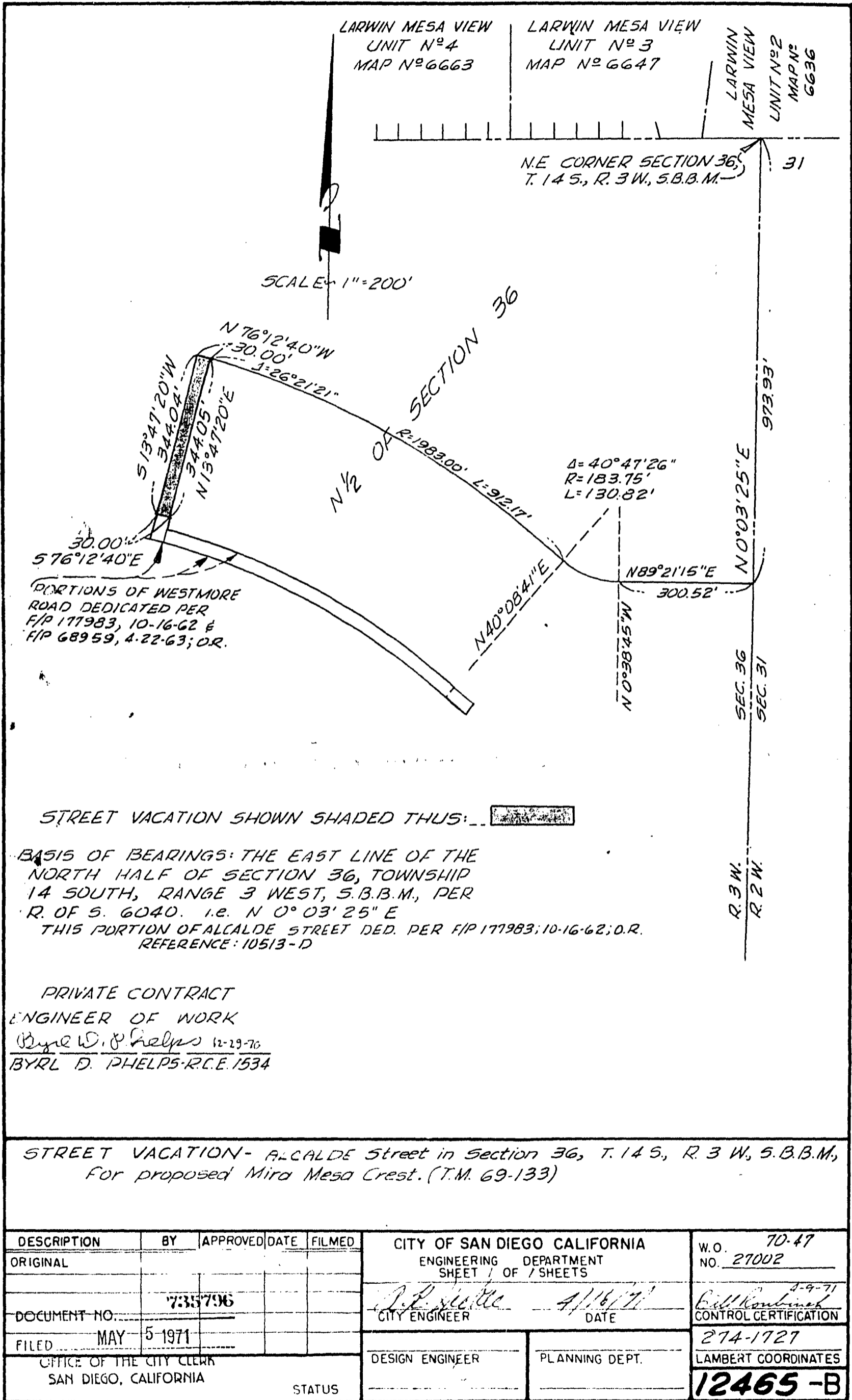
as more particularly shown on Map No. 12465-B, on file in the
