APPROVING MAP OF MIRA MESA CREST SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, Registered Civil Engineer, and entitled, "MIRA MESA CREST Being a subdivision of portion of Section 36, Township 14 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, State of California, according to United States Government Survey approved May 20, 1884.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street and portions of public streets, to wit: Westmore Road, and a portion of Worthing Avenue, portion of New Salem Street, portion of Westonhill Drive and portion of Mira Mesa Boulevard for public purposes, and said street and portions of streets are hereby declared to be public street and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Mira Mesa Boulevard and Westonhill Drive adjacent and contiguous to Lots 1 and 2; and any and all abutters' rights of access in and to Westonhill Drive adjacent and contiguous to Lots 4, 5 and 6, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public street and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
