and 40, and the ALLEY, BLOCK 309, PACIFIC BEACH,

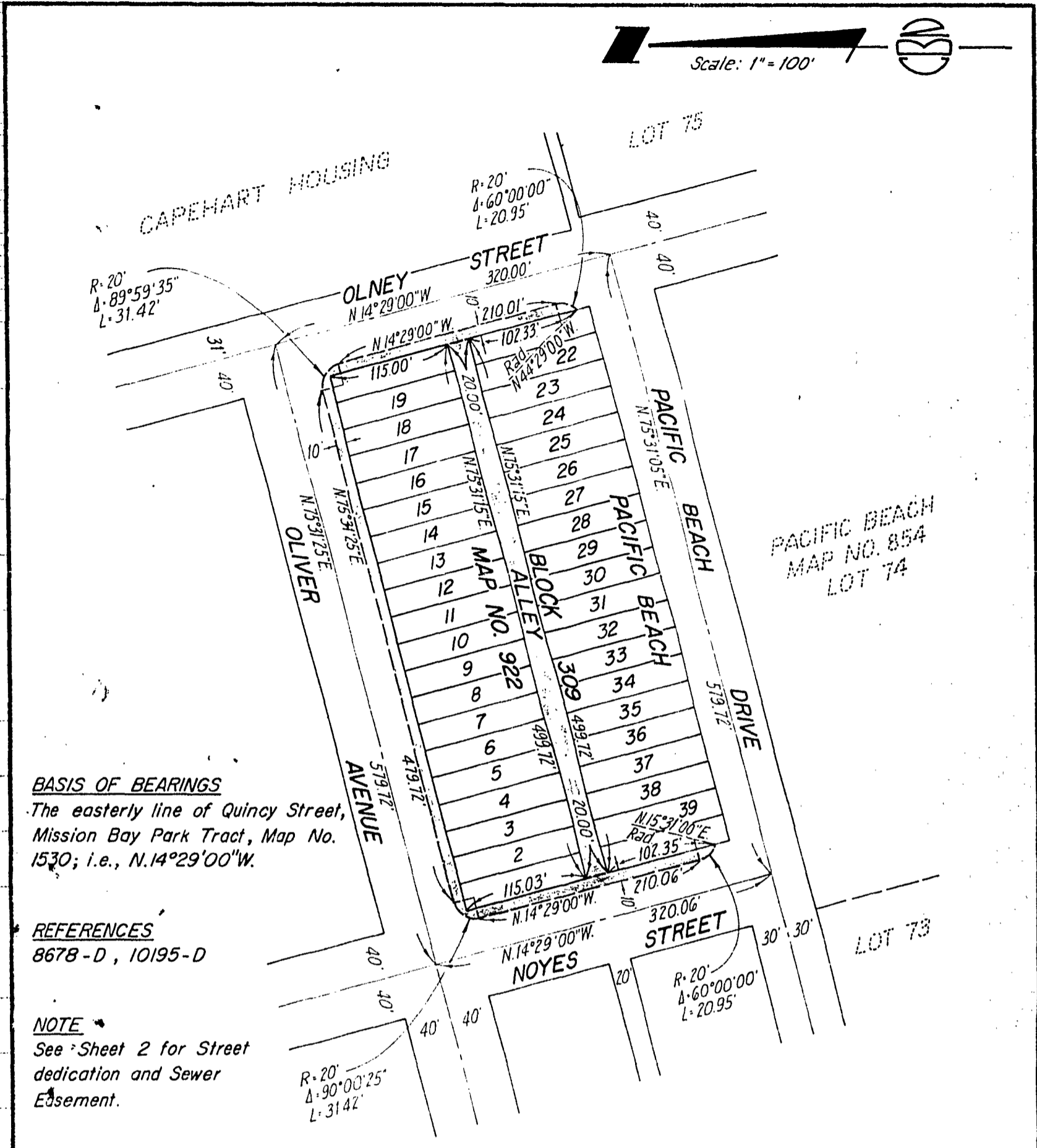
as more particularly shown on Map No. 12550-1-B, on file in the


