

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for a public street and incidents thereto, through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street and the same is hereby named PACIFIC BEACH DRIVE:

All those portions of Lots 21 to 40, inclusive, Block 309, Pacific Beach in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 922.

Beginning at the most Southerly corner of said Block 309; thence North $14^{\circ} 29' 00''$ West, 12.38 feet to a point in the arc of a 20.00 foot radius curve concave Northeasterly, a radial to said point bears South $15^{\circ} 31' 00''$ West; thence Southerly and Easterly along the arc of said curve, through a central angle of $29^{\circ} 59' 55''$ an arc length of 10.47 feet; thence North $75^{\circ} 31' 05''$ East, 479.72 feet to the beginning of a tangent 20.00 foot radius curve concave Northwesterly; thence Northerly and North-easterly along the arc of said curve through a central angle of $30^{\circ} 00' 05''$, an arc length of 10.47 feet to a point, a radial to said point bears South $44^{\circ} 29' 00''$ East; thence South $14^{\circ} 29' 00''$ East, 12.38 feet; thence South $75^{\circ} 31' 05''$ West, 499.72 feet returning to the Point of Beginning.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
