

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for
a public sewer and appurtenances thereto, through, over, under,
along and across the hereinafter described property, be, and
the same is hereby set aside for such public purposes:


All those portions of Lots 21 to 40,
inclusive, Block 309, said Pacific Beach,
together with that portion of the adjacent
alley closed by Resolution 202603, adopted
by the City Council on May 4, 1971, and
portions of Olney Street closed and Noyes
Street closed, being more particularly
described as a strip of land lying 5.00
feet Northerly and 10.00 feet Southerly of
the following described line:

Commencing at the most Southerly corner of
said Block 309, Pacific Beach; thence North
14° 29' 00" West, 12.38 feet to a point in
the arc of a 20.00 foot radius curve concave
Northeasterly, a radial to said point bears
South 15° 31' 00" West; thence Westerly and
Northwesterly along the arc of said curve
through a central angle 60° 00' 00" an arc
length of 20.95 feet; thence North 14° 29' 00"
West, 88.03 feet to the TRUE POINT OF
BEGINNING; thence North 75° 31' 15" East,
519.72 feet to a terminus in the Easterly
boundary of said Block 309, Pacific Beach.

Basis of Bearings: The Easterly line of
Quincy Street, Mission Bay Park Tract,
Map No. 1530, i.e. North 14° 29' 00" West.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
