

RESOLUTION No. 202836

Adopted on JUN 1 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PENASQUITOS, INC., an Illinois corporation, executed in favor of The City of San Diego, bearing date May 25, 1971, conveying to said City an easement and right of way for sewer purposes, through, along and across portions of Pueblo Lots 1278, 1291, 1292, 1294, 1303 and adjacent unnumbered Pueblo Lots, Pueblo Lands of San Diego, according to map thereof made in 1870 by James Pascoe, a copy of which said map was filed November 14, 1921, in the Office of the County Recorder of San Diego County, California, and is known as Miscellaneous Map No. 36, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
