BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$1,591,519 is hereby authorized out of the San Diego Wild Animal Park Recreation and Education Facilities 1970 Bond Fund, solely and exclusively for the purpose of providing funds for the purchase of the monorailroad transportation system at the San Pasqual Wild Animal Park from the San Diego Zoological Society.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to reimburse the San Diego Zoological Society for the payments made by said Society for the monorailroad transportation system upon the presentation by said Society of evidence satisfactory to the City Auditor and Comptroller and the City Manager that the items purchased have been delivered to the Wild Animal Park and that the Society has paid its contractor for these items.
