BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the land conveyed to The City of San Diego for the
purpose of a public street and incidents thereto, through,
over, under, along and across the hereinafter described pro-
perty be, and the same is hereby set aside and dedicated as
and for a public street and the same is hereby named HANCOCK
STREET:

All that portion of Lot 1, Block 1,
Subdivision of Pueblo Lot 277, according
to Map thereof No. 578, filed January 12,
1889 in the Office of the Recorder of San
Diego County more particularly described
as follows:

Beginning at the most Westerly corner of
said Lot 1; thence along the Northwesterly
line of said Lot 1, North 35° 57' 40" East,
20.28 feet; thence leaving said Northwesterly
line, South 00° 10' 48" West 24.98 feet to
a point on the Southwesterly line of said
Lot; thence along said Southwesterly line,
North 54° 05' 50" West, 14.61 feet returning
to the Point of Beginning.

Basis of bearings: The Southeasterly line
of Pueblo Lot 275, i.e. North 35° 57' 40"
East.

BE IT FURTHER RESOLVED, that the City Clerk of said City
is hereby authorized and directed to file a certified copy of
this resolution in the Office of the Recorder of San Diego County.
