

RESOLUTION No. 202877

Adopted on JUN 3 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of AMERICAN HOUSING GUILD SALES CORPORATION, a California corporation, successor in interest to CENTER MANAGEMENT, INC., a California corporation, executed in favor of The City of San Diego, bearing date March 23, 1971, conveying to said City an easement and right of way for street purposes through, over, and across portions of Pueblo Lots 1224 and 1788 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the Office of the County Recorder of said County of San Diego, November 14, 1921, as Miscellaneous Map No. 36, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named AVATI DRIVE; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named MORENA BOULEVARD.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
