APPROVING MAP OF KEARNY INDUSTRIAL PARK UNIT NO. 5 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:


Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "KEARNY INDUSTRIAL PARK UNIT NO. 5 Being a subdivision of a portion of Lot 78 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, and all of Lot 22 of Kearny Industrial Park Unit No. 2, in the City of San Diego, County of San Diego, State of California, according to the Map thereof No. 6241 together with a portion of Clairemont Mesa Boulevard as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Convoy Court, for public purposes, and said street is hereby declared to be public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
