

WHEREAS, heretofore, The City of San Diego and the County of San Diego entered into an agreement, which is on file in the office of the City Clerk as Document No. 734146, for the conveyance by said City to said County of 3,200 acres in the Lake Morena area; and

WHEREAS, the terms and conditions of said conveyance are more particularly set forth in said agreement; and

WHEREAS, the City should now quitclaim to the County of San Diego the Lake Morena Reservoir property, in accordance with said agreement; and

WHEREAS, the value of the property to be quitclaimed by the City is the sum of Eighty-Seven Thousand Nine Hundred Nineteen Dollars (\$87,919.00), which amount has been received by City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 736128, quitclaiming to the COUNTY OF SAN DIEGO, a body politic and corporate, the Lake Morena Reservoir property, as more

particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director for further handling.
