BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with FLORENCE CHAMBERS NEWKIRK, whereby Florence Chambers Newkirk quitclaims her interest in and to an existing road easement on City property and grants City a water pipeline easement, in exchange for a road easement, the right to remove a sufficient quantity of decomposed granite from the City's pit for the improvement of a road upon the new easement, a temporary license over the existing easement and payment of \$9,400.00, under the terms and conditions set forth in the form of agreement, on file in the office of the City Clerk as Document No. 736142.
