

RESOLUTION NO. 202914 JUN 10 1971

A RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A PUBLIC LIABILITY RESERVE FUND FOR THE PURPOSE OF PAYING CLAIMS AND RECEIVING UNEXPENDED FUNDS.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. The City Auditor and Comptroller is hereby authorized to establish a Public Liability Reserve Fund for the purpose of paying appropriate claims in excess of annual appropriations made for the City's public liability self-insurance program; providing that expenditures from said fund shall only be made by Council Resolution.

2. The City Auditor and Comptroller is hereby authorized to transfer to the Public Liability Reserve Fund, as soon as possible, all unexpended balances as of June 30, 1971 remaining in the following Damage Claim and Public Liability Insurance Activities:
