RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO  
AWARDING A CONTRACT TO IMPROVE AND TO CHANGE THE  
GRADE IN THE ALLEY, BLOCK 7, IMPERIAL HEIGHTS, AND  
THE ALLEY, BLOCK 2, STERLING PARK, AND TO IMPROVE  
AND TO ESTABLISH THE GRADE IN THE ALLEY, BLOCK 9,  
SILVER TERRACE.

hereby rejects all said proposals or bids except that herein  
mentioned and hereby awards the contract for doing said work  
and improvement to the lowest regular responsible bidder to  
wit: G. SPIKES & W. LOVE MASONRY & CEMENT CONTRACTORS  
at the prices named in the bid of said bidder on file in the  
office of the City Clerk.

The City Clerk is hereby directed to cause notice of this  
award to be published twice in the City Official Newspaper and  
to record notice of this award in the office of the County  
Recorder as provided in Section 5248 of the Streets and Highways  
Code.
