BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Change Order No. 1, dated May 18, 1971, heretofore filed with the City Clerk of said City as Document No. 736212 issued in connection with the contract between The City of San Diego and G. R. Henderson, an individual, for the construction of the Amherst Street Drain, said contract having been filed as Document No. 734206 in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$1,118.50, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to expend the sum of \$1,400 out of Flood Control & Storm Drain Bond Fund 727 and supplement Resolution No. 201681 in that amount, solely and exclusively for the purpose of providing funds for the contract changes described above.
