BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Pruyne Co., Inc. 2. Southern Equipment and Supply Co. 3. Butler's Mill, Inc. 4. Wilson F. Clark Co. 5. Gould Hardware & Machinery Co. 6. Smolan Industrial Supply and 7. Western Metal Supply Co. are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of SMALL TOOLS as may be required for the period of one year beginning July 1, 1971 through June 30, 1972 per prices on file in the Purchasing Department, as follows:

1. Pruyne Co., Inc. for Sections I & V, terms Section I 2% 10 days plus sales tax and Section V 1% 10 days plus sales tax, subject to price escalation not to exceed 10% of bid price.
2. Southern Equipment and Supply Co. for Section II, terms 2% 10 days, plus sales tax, prices are firm.
3. Butler's Mill, Inc. for Section III, terms net 30 days, plus sales tax, prices are firm.
4. Wilson F. Clark Co. for Section IV, terms net 30 days, plus sales tax, subject to price escalation not to exceed 10% of bid price.
5. Gould Hardware & Machinery Co. for Sections VI & IX, terms 2% 30 days, plus sales tax, subject to price escalation not to exceed 10% of bid price.
6. Smolan Industrial Supply for Section VII, terms 1% 10 days, plus sales tax, prices are firm.
7. Western Metal Supply Co. for Section VIII, terms 2% 30 days, plus sales tax, prices are firm.
